Introduction

This directory provides comprehensive resources for tobacco control advocates in California seeking to assist individuals facing two different situations:

1. Tenants, adversely affected by drifting smoke in apartment and multi-unit buildings, who need assistance resolving a dispute with their landlord or other tenant(s) regarding exposure to secondhand smoke; and
2. Injured smokers who want to seek legal representation to file suit against a tobacco company.

The resources are divided into three sections:

- **Resources for Tenants Affected by Secondhand Smoke** provides four options for resolving tenant disputes involving secondhand smoke in multi-unit residences. The services are listed by county. Many agencies listed provide services to a multi-county region. If you work in a county where any of these services is not available, try contacting an agency in a nearby county. In fact, some of the referral agencies are physically located in one county, but are listed under a different county's jurisdiction because they provide services there.
- **Statewide Resources on Secondhand Smoke Issues** provides information on agencies that offer technical assistance on various secondhand smoke-related issues across the state of California. It also describes some fact sheets developed by TALC that may be helpful to community members in resolving disputes and securing their rights.
- **Injured Smoker Attorney Referral List** provides contact information of four law firms in California that are currently willing to assist smokers who are suffering from tobacco-related health problems and may want to file suit against a tobacco company.

Resources for Tenants Affected by Secondhand Smoke

This section provides resources for resolving tenant disputes involving secondhand smoke in multi-unit residences.

- **Alternative Dispute Resolution (ADR) Programs.** For a nominal fee (about \$30), an ADR program can arrange a mediation session(s) between parties involved in a dispute. Each party will have an opportunity to state its side of the issue, with the goal of reaching a mutually satisfying resolution. A trained mediator facilitates the process. All parties must agree to participate, which can pose a challenge in heated disputes. ADR programs handle a wide variety of issues and are a good place to begin the process of resolving secondhand smoke-related tenant disputes.
- **Housing and Tenants Rights Advocacy Organizations.** These local organizations are designed to assist tenants with a variety of problems relating to rental housing. The services are free and may include making telephone calls and writing letters on behalf of the client, providing consultation, and/or offering mediation services. However, these agencies tend to be overwhelmed with requests from low-income renters with eviction disputes, and many stipulate that they cannot advocate on behalf of clients in secondhand smoke matters unless a doctor's note is provided stating a disability, or that the drifting smoke adversely affects the health of the client. Because they often focus on low-income households, there may be an income limit to qualify for their services.
- **Certified Lawyer Referral Services.** For a nominal fee (about \$30), these referral agencies of local chapters of the State Bar of California will arrange a half-hour consultation with an attorney, if one is available and willing to meet with a client. After the half-hour consultation, it is up to the client and the attorney to decide whether to bring a case and to arrange future payments for attorney services. Note that not all referral services will be able to make a referral to an attorney with experience and/or interest in the area of exposure to secondhand smoke.
- **County Health Department Tobacco Control Projects.** Each county has a state-funded Tobacco Control Project, which may know of additional resources or referrals for individuals affected by secondhand smoke.

This memo describes the rights of a disabled person if s/he works for an employer that does not comply with the state law on smoke-free workplaces, the Americans with Disabilities Act, the Federal Rehabilitation Act, or the California Fair Employment and Housing Act.

- **Employees' Rights When Complaining About Smoking at the Workplace**

This memo describes the rights of an employee who is retaliated against for complaining to a supervisor or a government agency about smoking in the workplace.
